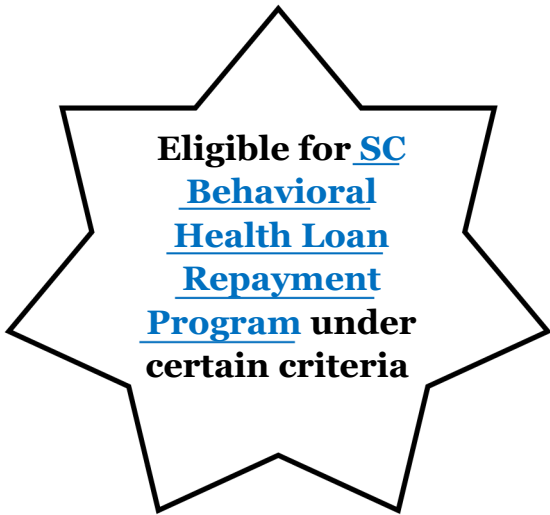

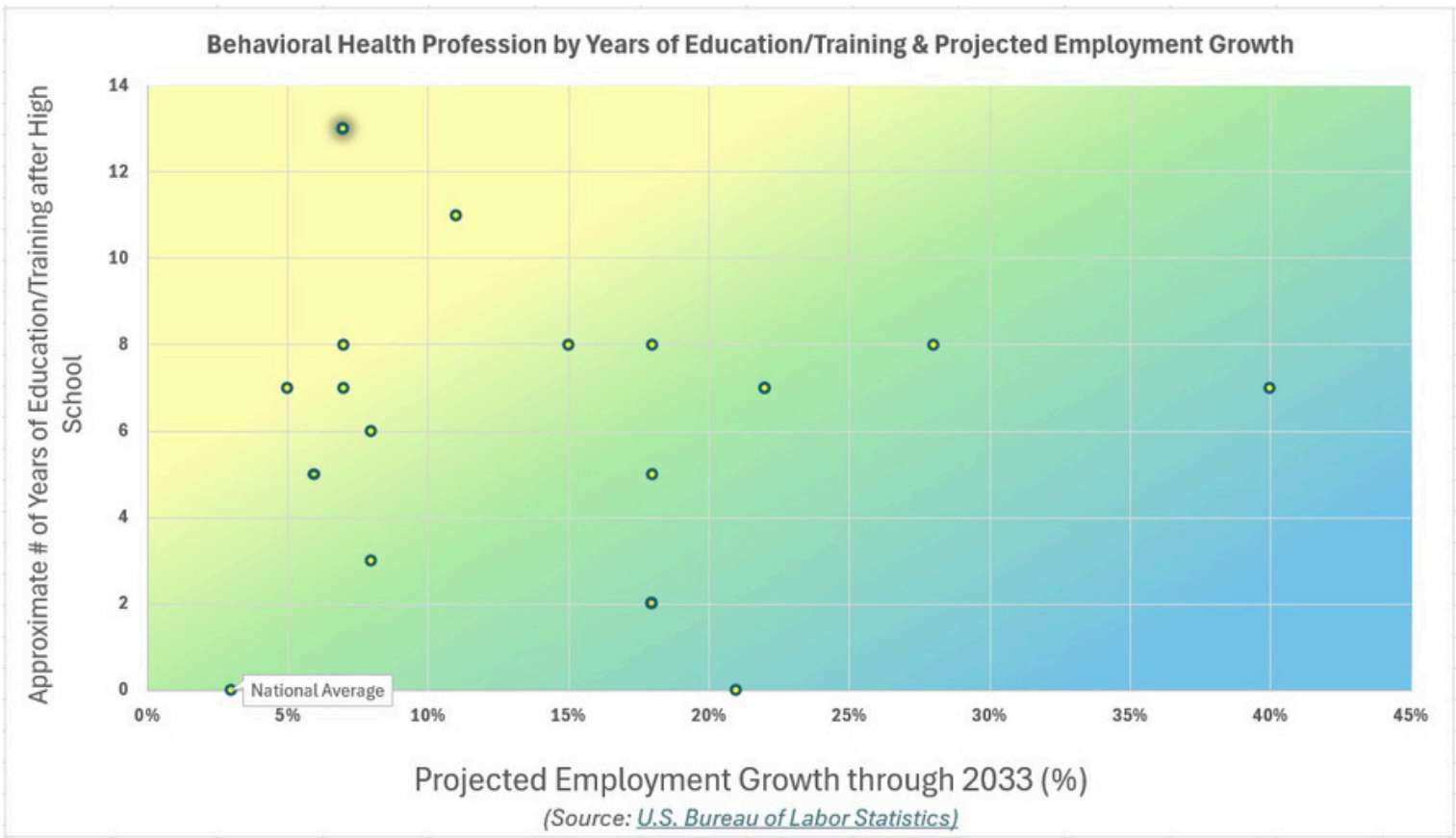

# Psychologist (PhD / PsyD)

**Job Description:** This professional performs mental health assessments and conducts talk therapy with individuals. They are not authorized to prescribe medication, as their focus is more on analyzing thoughts, feelings, and behaviors.

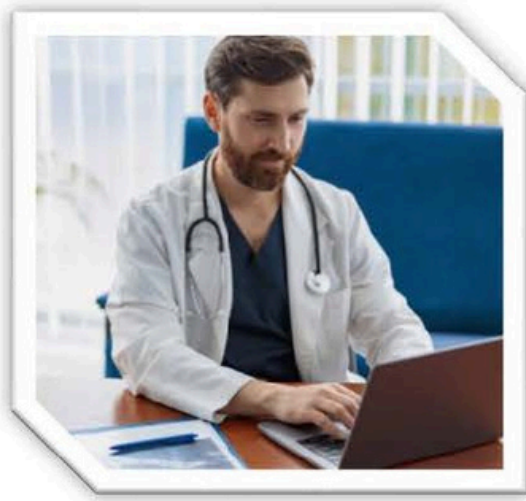

**Job Description:** Under the supervision of a licensed physician, this professional provides care for patients with mental illnesses. Their work includes assessments, medication management, and treatment.

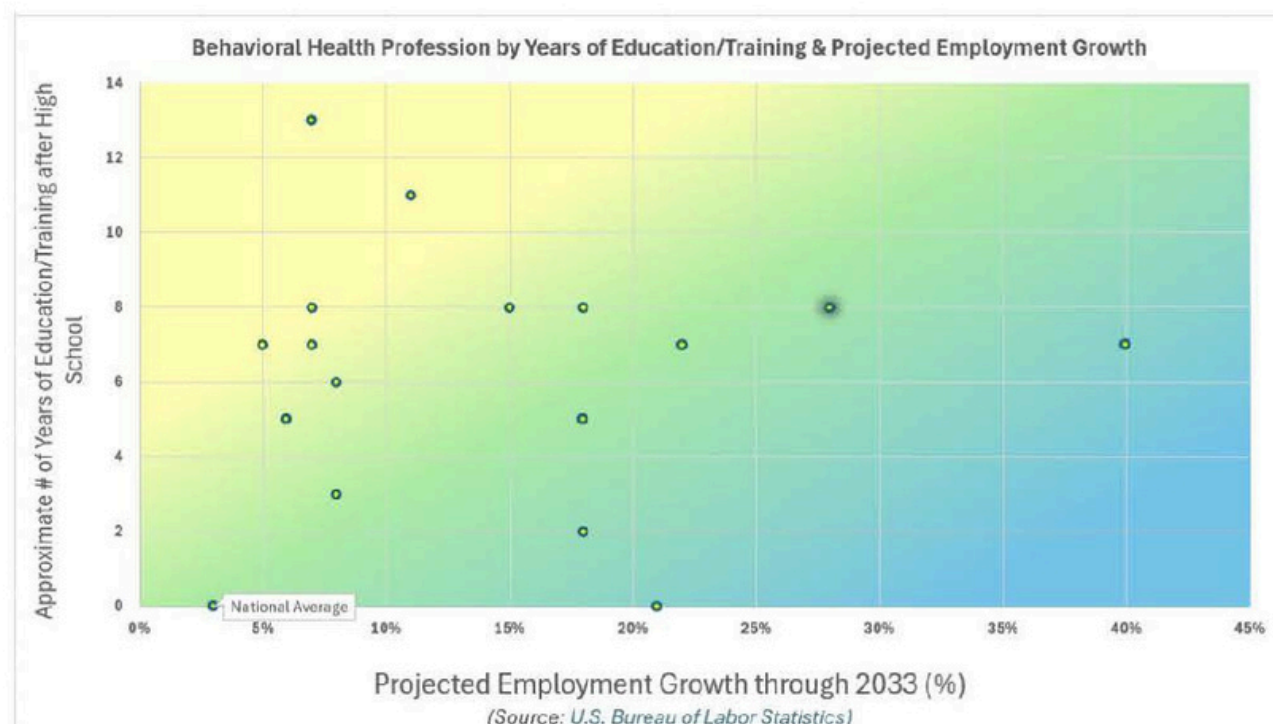

**Job Description:** Under the supervision of a licensed physician, this advanced nursing professional prescribes medication to individuals with mental health and substance use disorders. They also perform diagnostic assessments and psychotherapy for their patients.

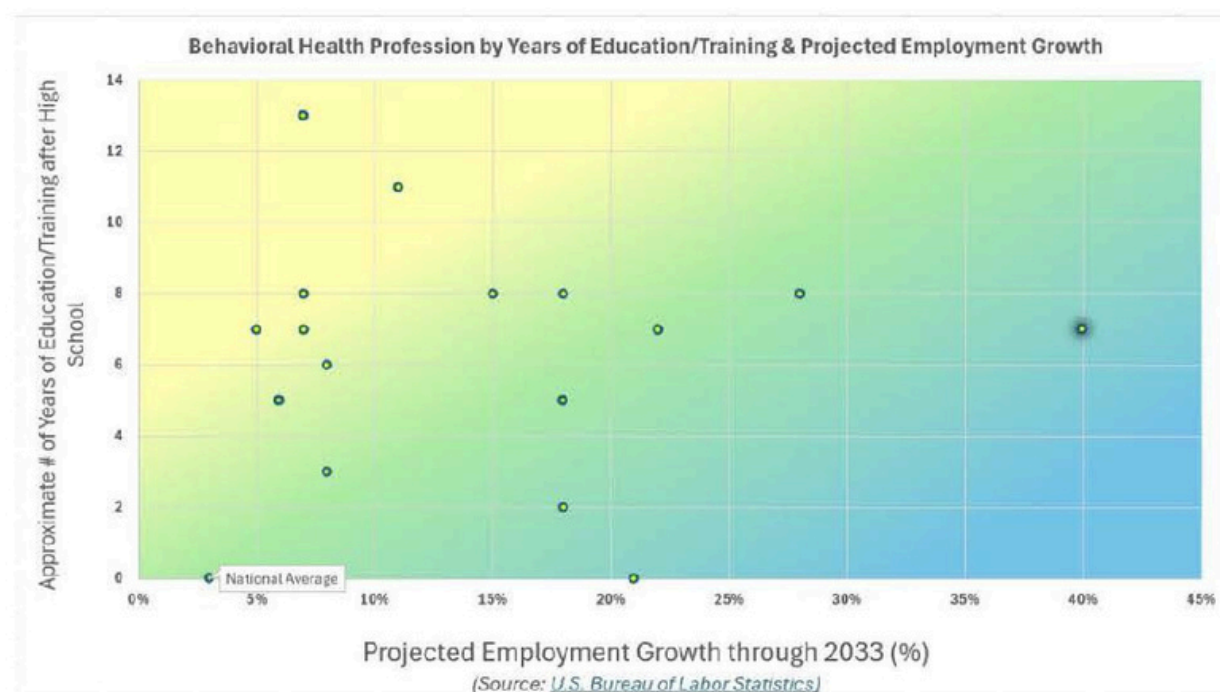

# Psychiatric / Mental Health Registered Nurse (RN)



**Job Description:** This professional works closely with other healthcare professionals to assist in developing and implementing treatment plans. They perform assessments, monitor vitals, and educate patients on available mental health resources.

# Certified Addiction Counselor, Level I (CAC I)



**Job Description:** This professional helps individuals struggling with substance use disorders (SUDs) through counseling, education, and support, working to develop treatment plans and promote recovery.

## **Educational/Experiential/Training Requirements**

1. **Associate's Degree** (*Human Services or related field*) or **Bachelor's Degree** (*Any major*)
2. **≥ 270 hours of coursework** related to core counseling functions set forth by the Addiction Professionals of South Carolina (APSC)
3. **≥ 4,000 hours of supervised field experience**
4. **≥ 150 hours of clinical supervision**

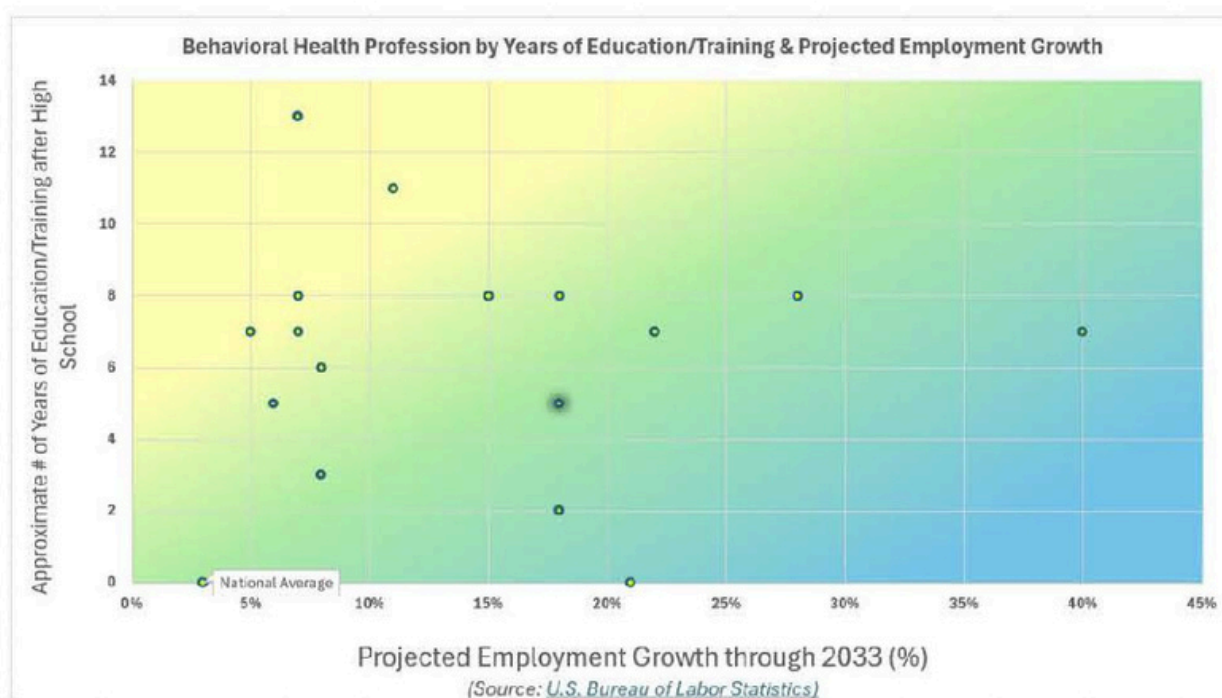

# Certified Peer Support Specialist (CPSS)

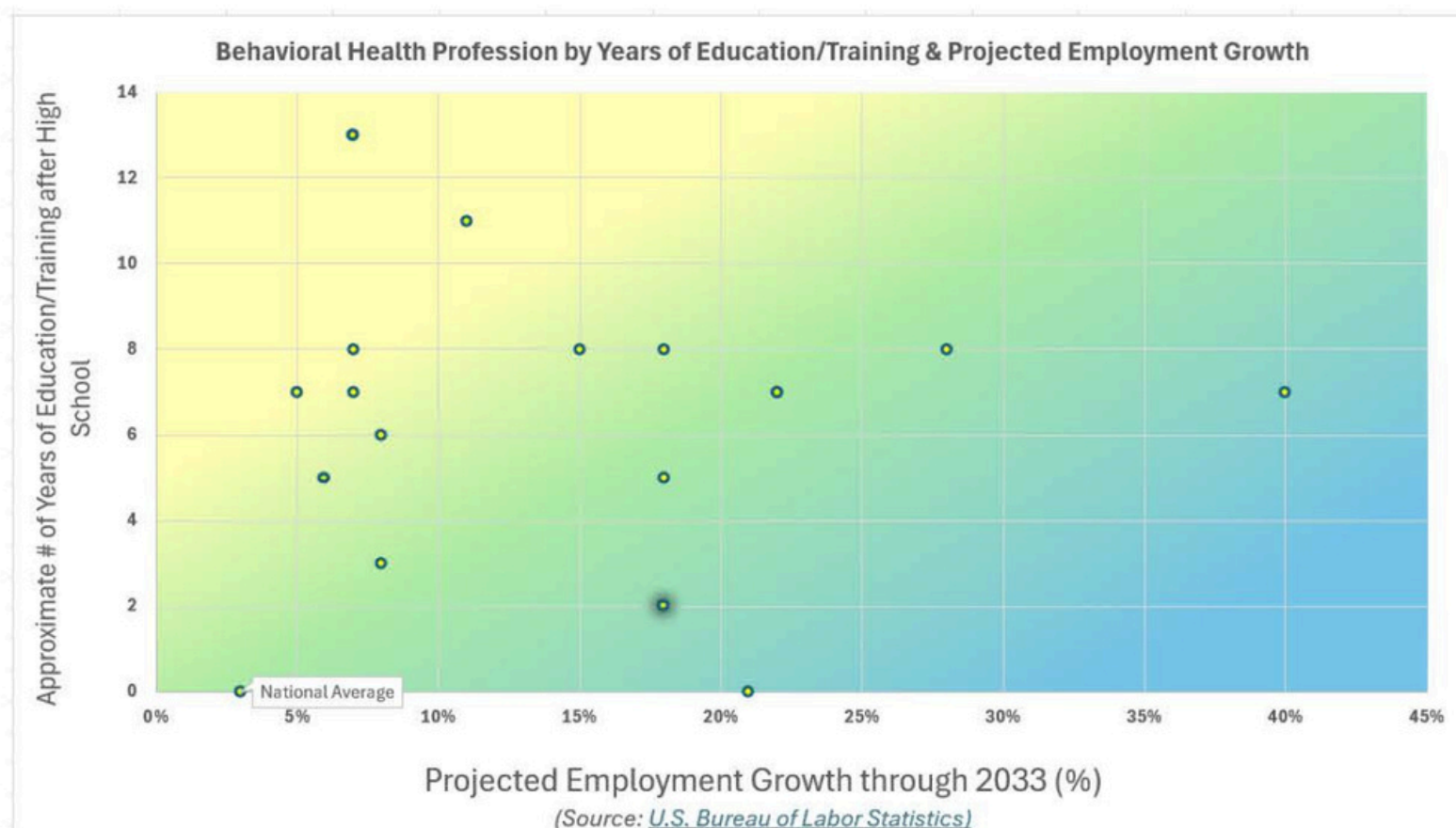

# Board Certified Behavior Analyst® (BCBA®)



**Job Description:** This healthcare professional assesses, analyzes, and develops behavior modification plans for individuals with behavioral challenges (often relating to developmental disabilities) by utilizing Applied Behavior Analysis (ABA) techniques in a variety of clinical settings.

**Average Salary (South Carolina):** \$69,630

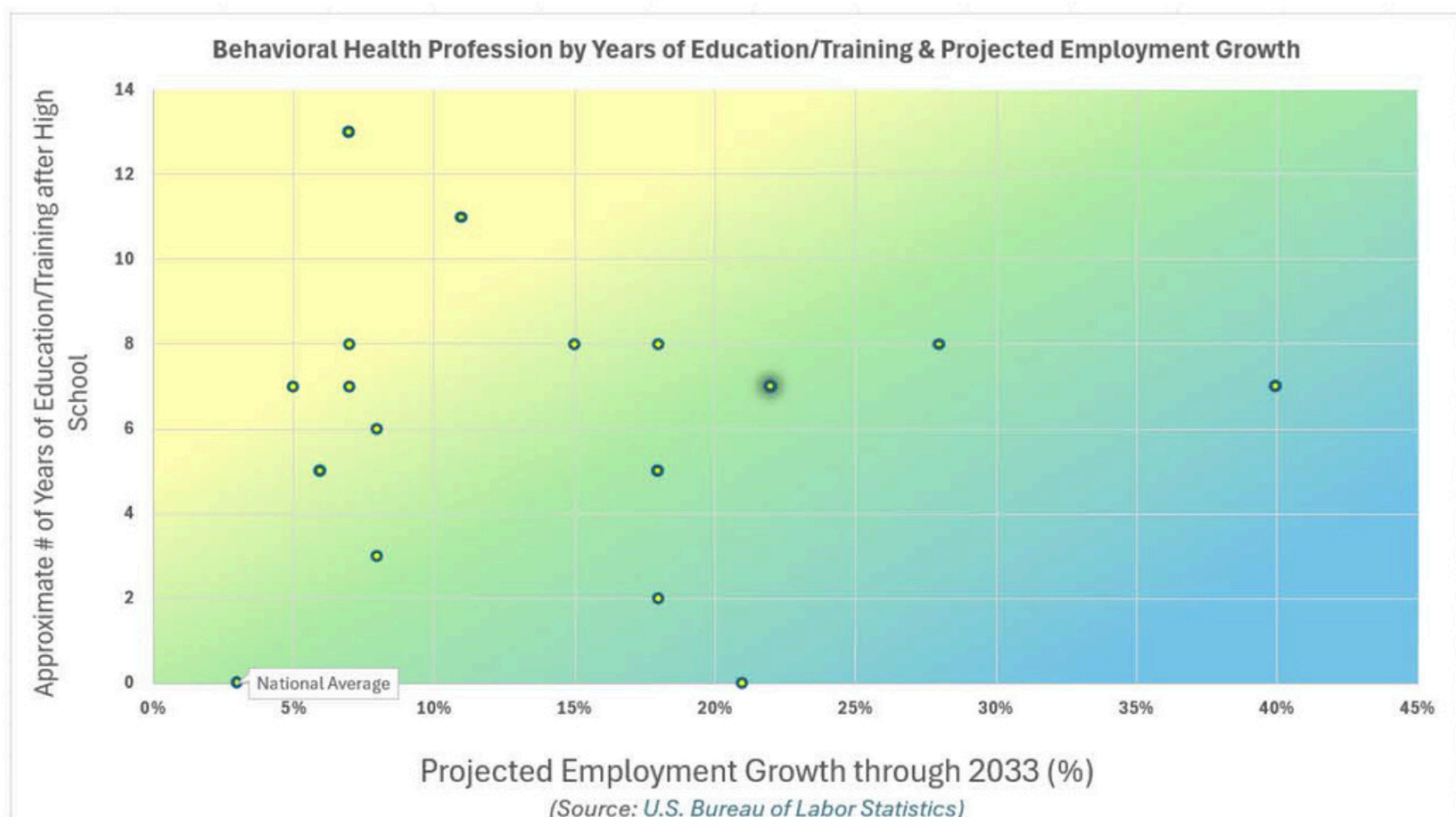

# Registered Behavior Technician® (RBT®)

**Job Description:** Under the supervision of a Board Certified Behavior Analyst® (BCBA®), this professional provides Applied Behavior Analysis (ABA) services to individuals with autism or other developmental disabilities, focusing primarily on acquiring skills and reducing unhealthy behaviors.

**NOTE:** Must be at least 18 years old to work in this profession.

**Average Salary (South Carolina):** \$34,664

**Average Salary (National):** \$37,355

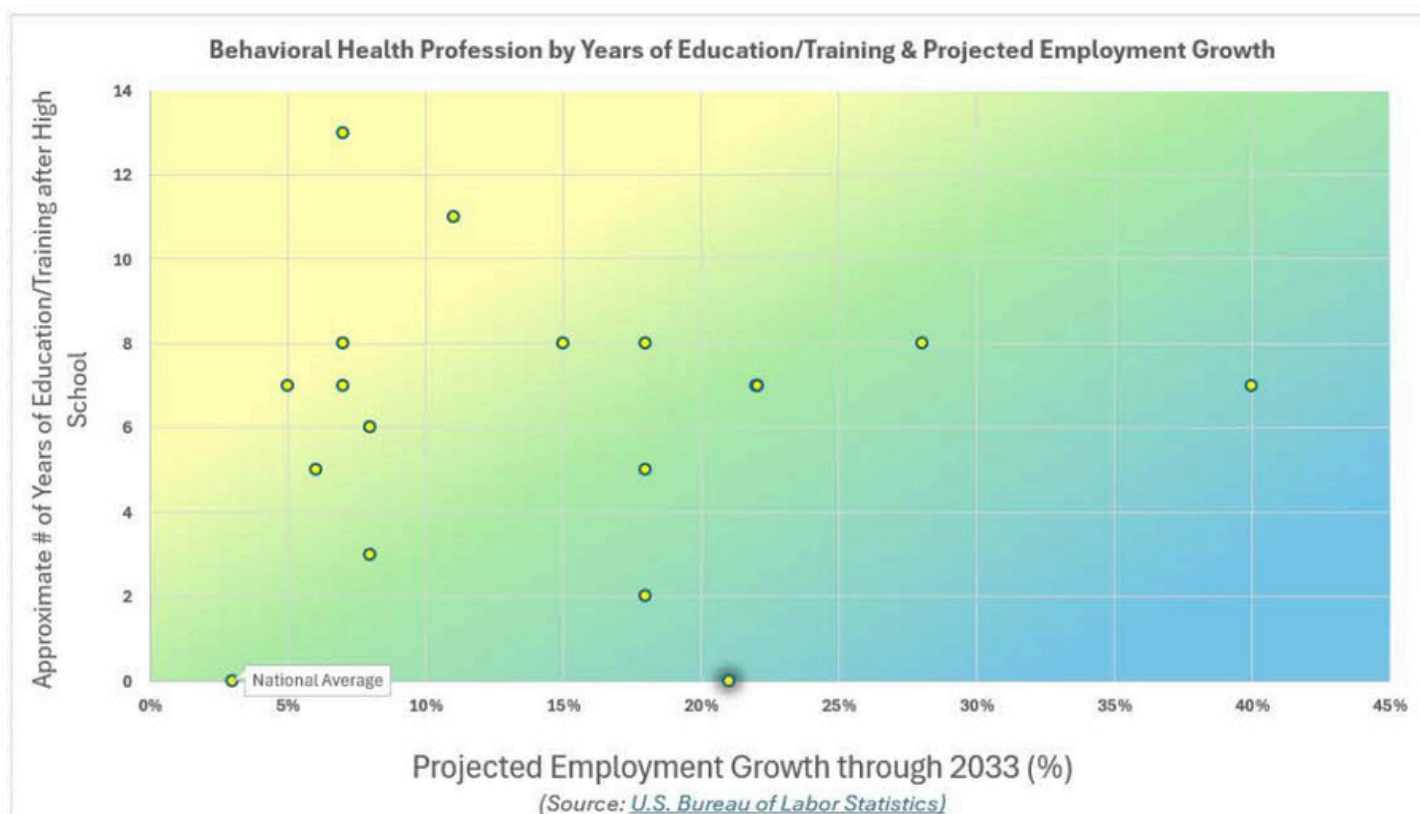

2. **Pass criminal background check**
3. **Completion of 40-hour training that meets requirements set forth by the Behavior Analyst Certification Board (BACB)**
4. **Completion of RBT Initial Competency Assessment, Behavior Analyst Certification Board (BACB)**
